Penalties for failure to obey a juror summons (sections 18-8-612 and 18-1-3-501, Colorado Revised Statutes): A knowing failure to obey the summons without justifiable excuse is a violation of section 18-8-612, C.R.S. and a class 3 misdemeanor.
